Available preservation technologies

Salting is an ancient technique; it is still widely practiced, but is coming under increasing environmental pressure. The immediate processing of fresh hides and skins is the ideal solution, but this is not practical unless the tannery is located next to a large slaughterhouse. The use of ice or refrigeration has been adopted in some countries to allow collection and short-term storage of hides, but this requires infrastructure and can be expensive. Short-term chemical cures have been advocated, but these also have their drawbacks, including autolytic damage. Antibiotics can provide limited preservation time, but they should not be used by the leather industry due to risks for human health (indiscriminate use can lead to antibiotic resistance). A more sustainable solution is required.

Inhibits bacterial growth – Busan 7600 contains a powerful bactericide that is effective on a wider spectrum of bacteria when compared to other chemical agents.

Inhibits collagenase enzymes – Busan 7600 contains a protease inhibitor which reduces harmful damage to the valuable collagen fibers. Protection covers enzymes from autolytic and bacterial origin. The combined action of the bactericide and protease inhibitor results in improved preservation performance and a more sustainable process from the viewpoint of human health and the environment. Busan 7600 provides higher flexibility and productivity in the tannery by replacing salt or brine curing and eliminating production steps. It is also an ethical choice because it does not contain antibiotics.

Effective and easy to apply

Busan 7600 provides better preservation when compared to chemical cures. Total preservation time will depend on dosage and environmental factors. Period of preservation will vary depending on the type of hides being treated, operation equipment, climate/temperature, and transport and storing conditions, as well as the required preservation time. Handling and application of Busan 7600 should be done according to all safety recommendations. The active ingredients have relatively low toxicity and are biodegradable ensuring minimal environmental impact. The determination of both the ideal dosage and preservation process should be done with the assistance of competent Buckman personnel.
